- \* Our products are delivered to the factory, transport of the building, transport insurance and customs affairs belongs to the BUYER.
- \* Supply of construction equipment required for transportation of building materials to the construction site and assembly of buildings belongs to the BUYER.
  - \* The passport, visa, travel, food and accommodation needs of the assembly and painting team belong to the buyer.
- \* Supply of the required work tools to the assembly team belong to the BUYER.
- \* The electrical supply required for the installation of the building belongs to the receiver.
- \* Delivery and protection of building materials coming to the construction site belongs to the BUYER.
- \* Garage doors belongs to the BUYER.
- \* Telephone, computer and UPS installations, fittings and construction work belongs to the BUYER.
- \* Building external lines. (Electricity, waste water, natural gas etc.) belongs to the BUYER.
- \* Kitchen cabinet, bathroom cabinet, sanitaryware, electricity material and construction work belongs to the BUYER.

- \* The Order gains certainty by paying the payment to our company by the buyer.
- \* If the order is canceled by the BUYER, the BUYER cannot claim a right in prepayment and order.
- \* In case of disruption in payments, our company may cancel the order partially or completely.
- \* The ownership of the goods subject to sale belongs to our company until all payments specified in the sales contract are fulfilled.
- \* In case of dispute, International Courts and Execution Offices are authorized.
- \* Earthquake, flood, fire and similar disasters, mobilization, strike, lockout and similar force majeure, delays due to accident or theft during transportation or assembly, changes after contract approval date, delays arising from material suppliers, order date will be added to the order.
